The park is provided by the Town to the citizens of Gordonsville and Smith County for their pleasure and enjoyment. Rental charge is for reservation of the **shelter only**; all other park facilities are always open to the general public. Shelters are **NEVER** double-booked for the day.

For the benefit of all, it is requested that the following guidelines be observed:

1. **Pick up keys** for use of the kitchen/bathroom at City Hall two days prior to use of the facility at the Police Department:

(Monday thru Friday from 8:00 a.m. to 4:00 p.m. Office is closed Saturdays/Sundays and all Holidays).

Utilization of kitchen facilities is not possible without key and personnel are not available outside office hours.

2. Do not permit children to play on tennis courts, stand or run on tables; and
3. Use the designated parking areas, **not the lawn**, for vehicles.

I/we further relieve the TOWN OF GORDONSVILLE, and its officers and employees, from any liability for loss or damage to any personal property that may be damaged, lost or stolen while on the premises.

In cases in which this release is signed by parents or guardians for a child under age 18, the parents or guardians assume the risk of injury to the child, or loss of or damage to personal property and release the city, and its officers and employees, from all claims, suits, damages, or judgments that may result from these injuries or losses that the parents or guardians might have against the TOWN OF GORDONSVILLE, or its officers or employees.
